

North Dakota University System Campus Solutions -- Financial Aid Pell Only Repackaging

In PeopleSoft Campus Solution V9, Pell Only Packaging is replaced by Pell Only Repackaging. As defined below, the repackaging works similarly to the way the Pell Only packaging plan worked in V8. This plan identifies students who are Pell eligible according to their ISIR and repackages the Pell only.

Recommend that prior to running the Pell Only Repackaging plan, you run disbursement authorization (**Financial Aid > Disbursement > Process Award Authorizations**) and run and save the **Authorization Failure List (NDU_0033_FA)** so you know who should be repackaged.

Note that the Repackaging process does not change awards that are "Locked". Awards are generally locked if posted manually (rather than letting the system assign the award amount). The system assumes locked awards are the way you want them to be.
